### **NC ABC COMMISSION APPROVES STORES REQUESTED BY RAMSEUR AND WARREN COUNTY ABC BOARDS**

RALEIGH – The NC ABC Commission held its regular monthly meeting today and approved penalties in excess of \$100,000 and/or imposed suspensions of three days or more on 84 businesses that hold permits to sell alcohol in the state. Fines are due Feb. 3, 2017, and suspensions begin Feb. 10, 2017.

The Commission also approved store locations requested by two local ABC boards:

- Ramseur ABC Board's first store, which will be located at 104 Weatherly Square, Ramseur;
- Warren County ABC Board's Littleton store, to be built at Lot 1 Stillwater Creek Drive and replacing an ABC store in Littleton that currently is being leased.

The Commission voted to approve three exemption requests under NC GS 18-B 1116 (b) by:

- Bull Durham Beer Co., LLC and Bull City Hospitality, LLC III.
- Huntington's of Carrboro, Inc., doing business as Tyler's Taproom; Pit Boss, Inc., doing business as Tyler's Taproom; T-3 Restaurants, Inc., doing business as Tyler's Taproom and Two Doors Distilling, LLC; Tyler Huntington, Daniel Kulenic and Robert Stover, Jr. IV.
- Oak City Market, LLC, doing business as Little City Brewing; Little City Tavern, LLC (retail) and East Hargett Entertainment (retail); Jonathan Seelbinder.
